11/18/24	<p>Welcome</p> <p>Current numbers</p> <ul style="list-style-type: none">● 305 K-6 and 80 ECE, Started the year at 307 and now we are down to 305 and about to drop 2 more. We have been losing students who have been moving to find more affordable housing. <p>District School Closure Update</p> <ul style="list-style-type: none">● Good news - we weren't chosen for school closure. Renteria was worried because we sit between two larger schools (Trevista and Swansea)● We are being asked to take on a center program (3-5 MIA program). We are being asked to take on a new classroom in addition to what we currently have in place. It will include the utilization of another classroom. We currently do not have an open classroom, so we will need to make some decisions about placements.<ul style="list-style-type: none">○ Are we going to take over Harrington's staff? Are we going to need to hire staff? This was Harrington's first year with the MIA program.● Another impact is that they want to change our school choice categorization from being an independent school zone to being part of the Greater Five Points Enrollment zone. What does that mean for us? Not sure yet what the difference is going to be and how that will impact us. We will need to try to recruit students from Harrington with tours. They do have transportation, but there are a lot of schools that will be competing for the same students.● Questions we have:<ul style="list-style-type: none">○ If the enrollment zone is changing, will our current families still be defaulted to come to our school?○ Will we be losing some of our current families?○ How will we recruit?○ Can we go to their school and visit?○ Will there be an open house or school fair at Harrington?○ Can we offer an open night here at school to invite families?● Plan for IAD Harrington Closure● Current School boundaries <p>Staffing Update</p> <ul style="list-style-type: none">● We currently have a 1.0 SPED Mild Moderate, 0.5 Upper Montessori position, 4 MIA para positions open (have recruited the 4 paras, but there is a hiring freeze currently) Can't push them forward until December 16th - we can plan on having that support after Winter Break.● <p>Bell Schedule</p> <ul style="list-style-type: none">● This week is the deadline for submitting Bell Schedule changes.● The biggest talking point is around Thursday and moving early release to 12:15 or 12:30, this would allow us to have a full four hours.● Original plan was that YMCA would take on any student on Thursdays who can't get picked up. We will discuss with YMCA so that it is an option next year. There is a program that has also offered to provide services for ECE students after school on Thursdays.● If we were lacking staff in YMCA on Thursdays if we have a large number, could we
